New/Old Business:

March 1 General Membership meeting—After discussion, four topics were chosen for the meeting: the incinerator issue, ICAR, BLM/ Meadowood update, and the State Park. Speakers for these issues will be solicited. A postcard announcement will be sent to all Mason Neck residents on about Feb. 24 listing the agenda items and encouraging citizens to come out to meet their neighbors and to bring ideas.

Gunston Hall Resolution: Marvin proposed and the Board agreed to send a resolution to the Governor, the Secretary of Education, Senator Puller, and Delegate Albo asking that the position of Education Coordinator at GH be re-funded and that the duties of the position be defined to include improving access and attendance.

ICAR: George Mason U. is now planning to build a smaller facility, closer to the one originally envisioned, and construction likely will start this summer. It has decided on a sewage treatment plant as the best option for handling waste materials but wants the smallest facility possible—maybe 5,000 gal/day or even less, depending on what is feasible.

Supervisor Hyland's Annual "Town Hall" Meeting will be on Saturday, attendance is encouraged.

Eagle Festival: Date set for April 16 at the state park, Board will discuss further a later date.

Membership promotion: Agreement to use the March 1 meeting as a vehicle to promote. Membership Chair Rodney suggested centralizing data on the MNCA web site, we will discuss with webmaster Peter.

Gunston Hall and ICAR: Sergio suggested that MNCA try to encourage collaboration between the two.

Letters of thanks to speakers at our March 1 General Membership Meeting – Marvin suggested sending, and also a letter to the VA Sec. of Education to thank him for his attendance at the meeting to discuss Gunston Hall on the same date (letter should also remind him of our previous communication to him on this issue). We will do both.

Incinerator Discussion – Peter mentioned the soot that falls on his property and Jerry noted that his neighborhood also gets diesel soot from trucks on Rt. 1 and I-95. Dave noted that in the early 90s the incinerator burned "controlled" (and possibly noxious?) trash materials from Europe to meet its tonnage requirement. Peter noted the need for air quality monitoring stations, preferably independently operated. **Motion made and passed** to send Supervisor Hyland a letter expressing MNCA's support for the option of Fairfax County purchasing the incinerator to maximize local control of its operations, to be followed by a second letter on the need for monitoring stations.

BLM—Mike and Marvin took the new director E. Lynn Burkett for a "tour" of the Neck to get acquainted with her and familiarize her with our interests.

MNCA General Membership Election Meeting—Date set for Tues., May 24. Calendar as follows: April 6--Board will appoint nominating committee; April 18 list of nominations due; nominations mailing sent to printer; April 25—letter and election materials mailed to all Mason Neck residents. 
ICAR: Next meeting with ICAR people will be on May 4.

Adopt-A-Highway Cleanup of Old Colchester: June 18, 9:00 to 12:00, was agreed as the next date for the quarterly cleanup, which is jointly sponsored by MNCA, the

Mason Neck Lions Club. and the Noman Cole Pollution Control Plant. Volunteers should meet in the Cranford Church parking lot.

Providence to Yorktown march – 230th **anniversary commemoration**: Jerry provided update – about 6-8 marchers will reach Colchester on Monday, Sept. 26. They may bivouac in Mason Neck West Park (near where the 1781 marchers encamped. Fairfax County Park Authority is coordinating.

New Business:

LCAC: Noted that their need for food donations is particularly high now.

Environmentally dangerous dumping? Jerry noted that there has been for some months a large pile of the bituminous material scraped up during road resurfacing operations and located on the truck/trailer/RV storage lot on Rt. 1, very close to

Giles Run, risking contamination of this environmentally sensitive area. He had contacted the County and the pile shrunk thereafter but has grown again. He now has notified Supervisor Hyland's office. Noted that Shannon Curtis in Fairfax's Storm Water Planning Division is a likely contact. **Motion passed** to send letter to Board of Supervisors Chair Bulova if needed after a response is received from Sup. Hyland. (Scott/Loges)

After contacting several local propane suppliers, Ferrell gas has continued to offer us the best rate for a Group Discount. They are quoting the Mason Neck residents of Cost + \$.0.559 IF we can match the number of clients based from last years effort. The current price is \$1.753 so the cost per gallon based on today's price would be \$2.312. If we do not have 27 homeowner's sign up the price goes up to Cost + \$.899 so the price would then be \$2.652 per gallon (again, based on today's price).

Last year we had 27 people sign up through this program. For the program discount to work we need 27 people this year. We do run some risk if we do not have 27 people fill out the attached form.
